Housing stories

Grenfell Tower tragedy

Government are currently focused on Grenfell Tower, appointing experts to take over the running of the housing department in Kensington and Chelsea, the public inquiry and further investigations into the causes. We are continuing to work with DCLG, taking part in discussions and offering advice where appropriate. Debbie Larner our head of practice is leading on this work and we are continuing to update our fire safety page, including a recent blog from Inside Housing by our chief executive Terrie Alafat calling for cross industry co-operation.

Consultations

Tackling unfair practices in the leasehold market

DCLG are consulting on prohibiting the sale of new build leasehold houses, limiting ground rents and protecting leaseholders from possession orders. Private rented sector review

Dr Julie Rugg from York University is carrying out a review of the private rented sector funded by the Nationwide Foundation, they are asking you to tell them what the private rental market is like in your area. Find out more about the review and how to respond here.

Northern Ireland

CIH Northern Ireland launched its new publication - Impact of welfare changes on rented housing in Northern Ireland - with the All Party Group on Housing at Parliament Buildings. Chaired by Nichola Mallon MLA, the event was attended by around 40 delegates including four MLAs. The launch was covered by eight media outlets.

We have met with the Department for Communities to discuss the recommendations of the report, particularly to have local housing allowance (LHA) reviewed in light of the UK government's



plan to apply LHA rates to social housing. We will continue to meet MLAs and MPs to raise awareness of the impact of the changes.

Scotland

CIH Scotland has released <u>comments on</u> the latest bi-annual homelessness statistics published by the Scottish Government on 27 June 2017, highlighting concerns about the slowing down of progress in reducing homelessness and the substantial number of people who continue to live in temporary accommodation.

CIH Scotland has also submitted its response to a recent Scottish Government consultation on energy efficiency and conditions standards in private rented housing. In the response, CIH Scotland calls for more ambitious energy efficiency standards for private landlords but 'with longer lead time.'

CIH Scotland has also published a 'what you need to know' briefing for members on the new Scottish Social Security Bill which outlines what's included in the new Bill and the next steps for the implementation of the newly devolved benefits.

Nominations for the <u>2017 CIH Scotland</u> <u>Excellence Awards</u> close in just over one month on 8 September 2017. There are sixteen award categories in total and the award winners will be announced at a special <u>Excellence Awards Dinner</u> on 27 October in Edinburgh.

Wales

CIH Cymru <u>responded</u> to the publication of the Welsh Assembly's Public Accounts Committee's inquiry into the regulation of housing associations in Wales. CIH Cymru welcomed the focus on tenant empowerment within regulation and the role of diversification as Housing Associations sought ways to fund the delivery of further homes and housing related support services.

CIH Cymru Director Matt Dicks provided evidence to the Welsh Assembly's Equalities, Local Government and Communities Committee as it undertook a one day inquiry into fire safety in high rise blocks in Wales. In giving evidence, we highlighted the quick response of the sector in reassuring tenants and outlined the challenges faced by members in operating fire safety strategies effectively.

CIH Cymru responded to the <u>homelessness</u> <u>figures</u> for 2016/17 welcoming the increase in the amount of people having their homelessness situation resolved, but warned that planned changes to welfare benefits could undermine further progress.
