# CANDIDATE SPECIFICATION

We are keen for applications from those working in the sector who have a real passion for and knowledge of housing, who are enthusiastic about the role housing can play in changing communities and changing lives and for those who want to contribute to their professional body.





We want to hear from candidates from all ages and stages of their housing career. Of course, you should be an ethical practitioner, who works with integrity and is inclusive and you will have your own skills that you bring to the role. You may or not have a current leadership role, but we can support your leadership development. Through your lived or professional experience, your networks and your knowledge, you should be able to contribute to the work of the CIH Scotland team and board.

#### ABOUT CIH AND THE SCOTLAND BOARD

CIH's purpose is to promote the science and art of housing and we do this through our sector leading qualifications, our industry wide training offer, our national events and conferences, guidance on emerging practice, and influencing the policy and political sphere.

We are effective because we are a membership organisation, and our members are at the heart of all that we do. The role of the Scotland board is to provide advice and support to the staff team in Scotland to deliver our goals and improve our member offer.

# The list below is not exhaustive but generally we expect the following of Scotland board members:

- To engage with CIH members and the wider housing sector in Scotland
- To support the Scotland staff team
- To gather policy and practice information to inform thinking and policy development
- To attend board meetings and key CIH Scotland events, conferences and awards
- To contribute to the effectiveness of the Board as a member of the team.

There are up to 15 members of the Scotland board and the role is voluntary/not renumerated, although expenses will be paid.

If you do join the board, we usually expect candidates to serve one three-year term. This is renewable once and most candidates do stay for six years. The board meets four times per year, alongside a planning day and usually meets on Friday mornings/afternoons. We have a mix of online and in-person board meetings and are gradually moving to more in-person meetings at our office in Norton Park Business Centre, Edinburgh.

The Scotland Board is a delegated board of the UK-wide Governing Board of CIH. This Board has ultimate responsibility for governance, financial propriety, and regulation of CIH and CIH Scotland.

## To support your professional body...

We want housing professionals with something to say. Those who can contribute to the development of policy and practice, help us grow CIH membership in Scotland and help us make the case for housing as a profession. If you are a passionate housing professional, then why not give something back to your professional body and profession.

You don't need to be a CIH member on application, but if accepted onto the board, you will be expected to join CIH.

# HOW TO APPLY

There are two ways to apply.

- You can submit a video application. This should be no more than five minutes, but
  please set out your housing experience, why joining the board is of interest to you
  and what you would bring to the role.
- You can submit a brief covering letter setting out your housing experience, why
  joining the board is of interest to you and what you would bring to the role.
- You may include a CV with either of these applications if you wish.

The closing date for submissions is **5pm on Friday 15 August 2025** and interviews will take place with the chair and vice chair of the CIH Scotland Board in September.
