

# Energy Performance Certificate (EPC) reforms survey Introduction

The government has issued a <u>consultation</u> on reforms to the Energy Performance Certificate (EPC) regime. The consultation proposes changing the headline metrics that are used in EPC certificates from the latter half of 2026. CIH members can read more about the consultation proposals in our guide <u>here</u>.

CIH welcomes the government's commitment to reforming EPCs, which require updating to support the UK's net zero targets. We know that EPCs are used in a range of ways by housing providers, especially to support the retrofitting of homes to EPC Band C. The government's fuel poverty and energy efficiency programmes, such as the Warm Homes: Social Housing Fund, use EPC status as a core eligibility criteria. We are also aware that many providers are currently increasing their EPC coverage when carrying out stock condition surveys.

The proposed reforms will therefore have an impact on the sector, and we are keen to understand the views of CIH members and non-members to help inform our response to the consultation.
